Training Content Will Include Overview of:

Indicator #6: Best practices in determining Least Restrictive Environment law and environmental coding practice (September & October sessions only).

Indicator #7: Reporting procedures and timelines, assessment of children's everyday functioning, the outcomes rating process, and data entry.

Indicator #12: The transition process, including elements of policy, best practice, interagency agreements, new timeline requirements and PPS reporting.
